



## **Yorkshire Warrior Participant's Agreement**

**Yorkshire Warrior Rules:** I agree to familiarise myself with and abide by all rules and regulations of Yorkshire Warrior Challenge Limited. I also agree to abide by all the rules of the venues which are Ridding Estate and Ripley Castle. I agree to comply with and under no circumstance challenge all instructions and decisions of Yorkshire Warrior Challenge Limited on matters before, during and/or after the event.

**Delay, Adjustment or Cancellation of the Event:** I understand and acknowledge that Yorkshire Warrior Challenge Limited may, under extreme circumstances have to delay or cancel the Yorkshire Warrior Event. "Extreme Circumstances" is defined as circumstances out of the control of Yorkshire Warrior Challenge Limited. These include extreme weather conditions, natural disaster, fire, strike, terrorism or any other unavoidable issue. I understand that Yorkshire Warrior Challenge Limited will make the decision of what is deemed to be an extreme circumstance and I will accept their decision. In the event of a delay, adjustment or cancellation of the Yorkshire Warrior as previously described, I understand that I will not be entitled to a refund of my entry fee or any other costs incurred in connection with the Yorkshire Warrior Event.

**Refunds:** I understand that once I have registered for Yorkshire Warrior, **all** fees and associated costs paid are non-refundable under **any** circumstance.

**Participant's Attitude and Behavior:** I agree to display appropriate behavior at all times before, during and after the event. This includes showing respect to other people and the event facilities. I understand that Yorkshire Warrior Challenge Limited has the authority to instruct and direct me in relation to my safe participation of the event and also has the authority to cease my participation in the Yorkshire Warrior event at any time if I am deemed to be putting myself or others at risk and/or if I am deemed to be acting unfairly and not within the spirit of Yorkshire Warrior Challenge Limited. I agree to cooperate with Yorkshire Warrior Challenge Limited and venue personnel, I understand that failure to do so or failure to obey Yorkshire Warrior rules could result in me being removed from the course at any time.

**Drugs & Alcohol:** I certify that I will not be under the influence of any drugs or alcohol on the day of the event that may in any way impair my ability to safely participate in the Yorkshire Warrior event.

**Photography:** I understand that all photographs and recordings captured of me during the Yorkshire Warrior event by Yorkshire Warrior Challenge Limited and/or its contractors and/or the media become the sole property of Yorkshire Warrior Challenge Limited.
